

# Validation Checklist Application for Tree Works:

## A. Works to Trees Subject to a Tree Preservation Order (TPO); Or B. Notification of Proposed Works to Trees in a Conservation Area (CA)

## **Common Invalid reasons**

There are many reasons as to why an application can be made invalid. This can lead to delays in validating and determining the application/notification. These are the top reasons for invalidity:

| Invalid reason  | Definition   |
|---|--|
| Missing or incorrect identification of trees and description of works for each tree | <ul> <li>All trees must be identified (species if known).</li> <li>All trees must be numbered to match TPO schedule (if known) and a sketch plan (TPO.)</li> <li>Full and clear specification for the proposed works.</li> <li>If applicable measurements of intended works should be given in meters or percentages.</li> </ul> |
| Missing reasons for proposed works (TPO)  | <ul> <li>For trees protected by a TPO, reasons must be given for the<br/>proposed works.</li> </ul>  |
| Missing or incorrect sketch plan (TPO)  | <ul> <li>For trees protected by a TPO, a sketch plan must be provided.<br/>clearly showing the location of the tree(s).</li> </ul>   |
| Missing information for (CA)  | Location of the trees for the proposed works.  |
